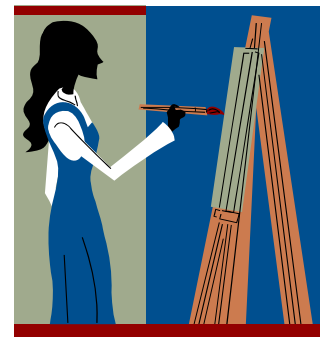

## **CALL FOR ENTRIES**

### **Juried Art Show and Silent Auction to Benefit the Partnership for Housing Foundation (PHF)**

Live Venue: Annapolis Yacht Club

Dates: June 27, 2014 4:30 – 8:00 PM (Live art show and opening reception)

June 25 – July 10 (online auction)

Theme: **Maryland, My Maryland**

#### **Qualifications for Juried Show and On-line Auction**

1. All applicants must be Maryland REALTORS®, REALTOR® staff, or sponsored by a REALTOR® member of the Maryland Association of REALTORS®.
2. Applicants must be at least 18 years of age (or, if younger, be enrolled as a high school student in Maryland, with parental permission to participate).
3. Art work may be two- or three-dimensional. Drawings, watercolors, mixed media, photographs, oil/acrylic paintings, giclée prints or sculptures are permitted entries. Do not submit jewelry or any crafted personal accessories.
4. Artists may only submit one entry for the show and on-line auction.
5. The deadline for entries is Friday, May 30, 2014.
6. Artwork must be submitted in digital format (.jpeg) by email to: [fern.dannis@mdrealtor.org](mailto:fern.dannis@mdrealtor.org).
7. All entries will be included in the online auction.
8. The artist may set a minimum compensation for their work or s/he may elect to accept 25% of the online bid. Of course, the artist may choose to donate their submission to the organization for its stated value and be eligible for a charitable tax deduction.
9. Bids for the artwork will be managed as a silent online auction by Bidding for Good.
10. Additionally, all artwork will be juried and prizes awarded based on the following categories:
  - Urban Scenes
  - Rural Scenes
  - Bay or Shoreline Scenes
  - Architectural Landmarks or Prominent Buildings
  - Portraits of a Community
  - “Home”
11. Winning artwork will be displayed at an “opening” event/show at the beginning of the Silent Auction; nonetheless, a minimum of one piece will be displayed from each participating Maryland County.
12. Selection of prizes by the jury will be announced on June 9, 2014.
13. If selected for the show, the artwork must be framed and suitably ready for gallery display (i.e., including backing and wire for hanging).
14. All artwork included in the show and all other entries will be available for online bidding and the proceeds will go to the Partnership for Housing Foundation.
